

During a period of five (5) years from the date of original purchase, mirror glass products supplied by Glaz-Tech Industries is warranted, to its immediate customer only, subject to terms and conditions of this Limited Warranty, not to contain silvering defects resulting in discoloration, black spots, or clouding of silver film that materially obstructs the mirror image of the vision area.

In the event that the mirror product contains defects as stated above, Glaz-Tech Industries must be notified in writing at the plant from which the purchase was made. Liability under this Warranty is limited, at Glaz-Tech exclusive option, to replace such mirror product F.O.B. nearest Glaz-Tech location or refund 100% of Glaz-Tech's original selling price for such mirror product. Labor costs are not covered by this Warranty. This Warranty does not apply to replacement mirror product beyond the Warranty period applicable to the original mirror product. Glaz-Tech reserves the right to inspect any mirror product that is alleged to be defective prior to its removal from the glazing system installation or fabrication location.

Glaz-Tech Industries liability shall be limited solely to its responsibilities under this Warranty. In no event shall Glaz-Tech Industries be liable to any person or entity for indirect, special, incidental or consequential damages or charges for any reason.

Glaz-Tech Industries mirror products sold conforms to the quality standards set forth in ASTM (American Society for Testing and Materials) C 1503-01. This standard replaces previously used federal specifications DD-M-411-C and General Services Administration CID-A-A 3002. The glass used to manufacture Mirror is defined in ASTM C 1036 Section 4.1.

## CONDITIONS THAT WILL VOID THE WARRANTY THIS WARRANTY IS VOID UNDER ANY OF THE FOLLOWING CONDITIONS:

- 1. The mirror glass or coating/paint backing surface is broken or fractured.
- 2. The mirror glass is subjected to standing water or other liquids.
- 3. The mirror glass is damaged or altered by handling, storage, fabrication, or installation contrary to Glaz-Tech's written instructions attached and incorporated by reference or industry standards promulgated by GANA-Glass Association of North America, which includes these former independent associations: FGMA, LSGA, and GTA; SIGMA -Sealed Insulating Glass Manufacturers Association; IGMAC-Insulating Glass Manufacturers Association of Canada; NAAMM-North American Association of Mirror Manufacturers; and AAMA-American Architectural Manufacturers Association or equivalent.
- **4.** The mirror glass or coating/paint back surface is attacked by incompatible glazing lubricants, soaps, gaskets, sealants or silicones, or cleaning fluids; moisture runoff; gluing or by attachment of non-Glaz-Tech applied films; direct contact with paints adhesives, solvents or insulation; or exposure to solvent or chemical fumes.
- 5. The mirror glass was discarded or destroyed.
- 6. The mirror glass is installed in swimming pool enclosures, bath enclosures, or commercial refrigeration products.
- 7. The mirror glass is installed or used in an application other than indoor use.

EXCEPT FOR THE EXPRESS WARRANTY DESCRIBED ABOVE, THERE ARE NO EXPRESS OR IMPLIED WARRANTIES OF ANY KIND AND THERE ARE NO WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE WITH RESPECT TO THE MIRROR GLASS OR ANY PART OR COMPONENT THEREOF AND NO WARRANTY SHALL BE IMPLIED BY OPERATION OF LAW OR OTHERWISE.

No variation, change, employee, agent, representative, distributor or seller has the authority to change or modify this warranty, either verbally or in writing.
